

### Members to Vote On Constitution and By-Laws Amendments At Regular Meeting of March 14

Pursuant to Article XVI, "Amendments," of the By-Laws of the Overland Park Host Lions Club, the Board of Directors has submitted amendments for a vote by the membership at the regular club meeting on March 14.

The Board of Directors at its March 1 meeting unanimously recommended that club members vote in favor of the proposed changes.

Amendments to be considered include all or parts of the following By-Laws: **Article VII: Officers:** (number of vice presidents); **Article VIII: Board of Directors: Sections A and G** (size of board and election of directors); and **Article X: Vacancies** (procedures for filling).

## Text of Proposed Constitutional Amendments

### ARTICLE VII

#### Officers

#### Section D. DUTIES.

(3) **VICE-PRESIDENTS:** There shall be ~~three (3)~~ **two (2)** Vice-Presidents: a 1st Vice-President, **and** a 2nd Vice-President ~~and a 3rd Vice-President~~. If the president is unable to perform the duties of his/her office for any reason, the vice president next in rank shall occupy his/her position and perform his/her duties with the same authority as the president.

**If, prior to the first election following the adoption of this Section, there is any vacancy in the position of a Vice President who has years remaining on his/her term, the Nominating Committee shall not act to fill such vacancy, provided however that a minimum of two (2) Vice Presidents is ensured for the next year. At the second and each subsequent election following the adoption of this Section, one (1) Vice President shall be elected.**

Each vice president shall, under the direction of the president, oversee the functioning of such committees of this Club as the president shall designate.

### ARTICLE VIII

#### Board of Directors

Section A. The members of the Board of Directors shall be the president, immediate past president, ~~the three (3)~~ **two (2)** vice presidents, secretary, treasurer, Lion tamer, tail twister, membership director and ~~six (6)~~ **four (4)** elected directors.

Section G. One ~~third (1/3)~~ **half (1/2)** of the directors shall be elected annually and shall take office on the July 1st next following their election, and shall hold office for ~~three (3)~~ **two (2)** years from that time, or until their successors shall have been elected and qualified, ~~with the exception that at the first election held after the adoption of this Constitution and By-Laws, one third (1/3) of the directors shall be elected for three (3) year terms, one third (1/3) of the directors shall be elected for two (2) year terms and the other one third (1/3) of the directors shall be elected for one year terms.~~

**Nothing in this Section shall be construed as requiring directors elected in the two years prior to its adoption to resign or be removed from their respective positions.**

**If, prior to the first election following the adoption of this Section, there is any vacancy in the position of a Director who has one or more years remaining on his/her term, the Board of Directors may at its discretion advise the Nominating Committee not to act to fill such vacancy, provided however that a minimum of four (4) directors is ensured for the next year.**

### ARTICLE X

#### Vacancies

Section A. If the office of president or of ~~any~~ **first** vice president shall become vacant for any reason, the vice presidents **next in rank** shall advance in office, ~~according to their rank~~. In the event such provision for advancement shall fail to fill the office of president, or first ~~or second~~ vice president, the Board of Directors shall thereon call a special election, giving each member in good standing prior two (2) weeks notice of the time and place thereof, which time and place shall be determined by said Board, and such office shall be filled at said election meeting.

In the event of a vacancy in the office of ~~third~~ **second** vice president, the Board of Directors may appoint a member to fill the unexpired term.

## Maybe you've already heard this one . . . It's a real groaner!!

The four Goldberg brothers, Lowell, Norman, Hiram, and Max, invented and developed the first automobile air-conditioner. On July 17, 1946, the temperature in Detroit was 97 degrees.
