Nut-sale fund-raising effort doing well; Alas: 57 bags still remain to be sold

Pecans (some milk-chocolate-covered), walnuts, mixed nuts and cashews—a wide assortment of nuts is being sold by our members in a new fund-raising project.

The nut project was approved by the Board of Directors last Fall and was intended to replace the traditional Candy Days of years past.

So far, over \$2,800 has been raised. Some Lions still have additional money to turn in. And there is still a fair-sized inventory yet to be sold. Only six bags of pecans remain and 15 to 20 bags each of walnuts, cashews, and mixed nuts are on hand.

A profit of almost \$2,000 can be made if all bags of nuts get sold. (Our cost was \$1,985 for 13 cases.) In addition to replacing Candy Day funds, this profit will also help make up for revenue that was lost from food sales at the Overland Park Fall Festival in September because of the cold, rainy weather.

- These nuts are *fresh*, from this year's crop, not a year old or more;
- Our selling price is less than that at most grocery stores.
- Profits will help support the Kansas Lions Sight Foundation, the KU Eye Clinic, and KU Audio-Reader.

If you want to buy some nuts for yourself—or to take some to sell—contact **Neal** or **Beverly Nichols** at 913-642-7520 and we will get them to you right away.

The nuts are packed in 12-ounce bags and sell for \$9 per bag.

If every member who hasn't yet joined in this effort would sell only two or three bags, we'd be almost completely sold out and have money in the bank!

As they say in the news business, "This just in!" One of this year's customers e-mailed a request for us to keep her in mind when next year's nuts go on sale.
